# Instruction section for tax filers unable to use the FUTURE ACT DIRECT DATA EXCHANGE

## **Request an IRS Tax Return Transcript**

If you do not meet the requirements or choose not to use the FUTURE ACT DIRECT DATA EXCHANGE [FADDX], you are required to submit yours, and your spouse's if married, IRS tax return transcript to the financial aid office. If you are married and you and your spouse filed separate 2022 tax returns, you must submit tax return transcripts for both you and your spouse.

<u>Online Request</u> - go to www.IRS.gov and click on the "Get Transcript of Your Tax Records" link. Click "Get Transcript ONLINE" or "Get Transcript by MAIL". Make sure to request the "IRS Tax Return Transcript". <u>Telephone Request</u> – 1-800-908-9946 <u>Paper Request Form</u> – IRS Form 4506T-EZ or IRS Form 4506-T

**Note:** Once you have filed your return with the IRS it may take up to two weeks for IRS income information to be available for electronic tax return filers, and up to eight weeks for paper tax return filers. You must wait until your IRS income information is available before choosing either option.
