# Financial Literacy Fair at Old Westbury – Spring 2023

In following up on the success of prior years' Financial Literacy Fairs, this year's Fair was held in=person in the Student Union Multi-purpose Rooms. The Financial Literacy (FLOW) Committee began planning in early fall. The Fair included an Exhibition Hall and eight presentations throughout the day. Approximately 350 students, faculty, staff, prospective students, vendors, and visitors participated.

Attendees learned more about financial literacy from representatives of various financial institutions (banks, credit unions, insurance, financial planners, etc.) through seminars and panel discussions.

The first Financial Literacy and Innovation Plan Competition, sponsored by the Old Westbury School of Business and Teachers Federal Credit Union (TFCU), closed out the day. Eight Old Westbury students presented and competed for a \$500 savings account that was selected by TFCU panel of experts.

#### 1) FAFSA Processing for 2022-2023 is in Process

Federal Financial Aid processing for 2022-2023 should be completed as soon as possible! Complete the FAFSA at <u>https://studentaid.gov/h/apply-for-aid/fafsa</u>

For assistance in completing and submitting your FAFSA form, enroll in the FLOW "FAFSA" Course noted below. It is also available in Spanish!

#### 2) FAFSA Availability for 2023-2024

The Federal Department of Education FAFSA site for **2023-2024** is open. Be sure to complete next year's FAFSA at <u>https://studentaid.gov/h/apply-for-aid/fafsa</u> Old Westbury school code is 007109.

#### 3) <u>eRefunds</u>

eRefund (direct deposit) is a method of payment which electronically credits your checking or savings account for financial aid or other credit balances in your student account. Instead of receiving a paper check, electronic deposits are quickly processed through the National Automated Clearing House. We strongly encourage you to set up a direct deposit bank account. It's the fastest, most secure, and environmentally friendly way to receive your refund.
