

# 2021–2022 Verification Worksheet V1– Dependent Student

Your 2021–2022 Free Application for Federal Student Aid (FAFSA) was selected for review in a process called verification. The law says that before awarding Federal Student Aid, we may ask you to confirm the information you reported on your FAFSA. To verify that you provided correct information our financial aid advisor will compare your FAFSA with the information on this worksheet and with any other required documents. If there are differences, your FAFSA information may need to be corrected. You must complete and sign this worksheet, attach any required documents, and submit the form and other required documents to the Office of Financial Aid. We may ask for additional information. If you have questions about verification, contact your financial aid advisor as soon as possible so that your financial aid will not be delayed.

**Instruction Section for Tax Filers**

**Option 1 – Use the IRS DRT Tool**

The best way to verify income is by using the IRS Data Retrieval Tool (IRS DRT) that is part of FAFSA on the Web at FAFSA.gov. If you have not already used the tool, go to FAFSA.gov, log in to your FAFSA record, select "Make FAFSA Corrections," and navigate to the Financial Information section of the form. From there, follow the instructions to determine if you are eligible to use the IRS Data Retrieval Tool (IRS DRT). If you need more information about when, or how to use the IRS Data Retrieval Tool, please contact the Financial Aid Office.

**Option 2 – Request an IRS Tax Return Transcript**

If you do not meet the requirements or choose not to use the IRS Data Retrieval Tool, you are required to submit yours, and your spouse's if married, IRS tax return transcript to the financial aid office. If you are married and you and your spouse filed separate 2019 tax returns, you must submit tax return transcripts for both you and your spouse.

**Online Request** - go to www.IRS.gov and click on the "Get Transcript of Your Tax Records" link. Click "Get Transcript ONLINE" or "Get Transcript by MAIL". Make sure to request the "IRS Tax Return Transcript". **Telephone Request** – 1-800-908-9946 **Paper Request Form** – IRS Form 4506T-EZ or IRS Form 4506-T

**Note:** Once you have filed your return with the IRS it may take up to two weeks for IRS income information to be available for electronic tax return filers, and up to eight weeks for paper tax return filers. You must wait until your IRS income information is available before choosing either option.
