Introduction

A sanction is a requirement or status that is imposed as a result of either accepting responsibility or being found responsible for violating the College's Code for Student Conduct.

Each campus conduct case is unique and, therefore, it is not possible to establish a list of prescribed sanctions covering every possible violation of the Code for Student Conduct. This guide is designed to cover many, but not all, possible behaviors that would violate the Code.

This guide is intended to cover a range of sanctions that would be considered appropriate for first-time offenses; subsequent and/or recidivist violations of this Code may result in suspension or expulsion from the residence halls, or suspension or expulsion from the College. <u>Moreover, the College's response and imposition of sanctions is NOT restricted to the sanctions listed in this guide.</u> Sanctions are determined on a wide variety of factors, including but not limited to, the severity and seriousness of the Code violation, the violation's impact on the College and local community, the number of violations that occurred during an incident, a student's prior conduct disciplinary history, etc. It should be noted that a student with no prior disciplinary record may be assigned a sanction, commensurate with the violation, up to and including expulsion from the residence halls, suspension, or expulsion.

The sanctions outlined in this guide describe a student's status (reprimands, probations, suspension, and expulsions). However, other sanctions listed in the Code for Student Conduct can also be applied in addition to those mentioned in this guide, for example, educational workshops, reflection and research papers, community service, etc.
