• Adj. Prof. Sevim Oztimurlenk has published the article titled An Empirical Study On Personal Factors Affecting Emotional Intelligence Levels Of Employees In The U.S. The purpose of the study is to explore the impact of some personal factors (i.e., gender, age, education, marital status) on employees' emotional intelligence levels in the service sector in the U.S. Using a questionnaire survey, pertinent data is gathered from a group of 98 employees who work in different companies and industries in New York and New Jersey. Employees' EI is measured using Wong and Low Emotional Intelligence Scale (WLEIS). This study differentiates itself by focusing on employees working in companies with more than 1000 employees in the service sector and who have at least two or more reporting employees. Only the most commonly examined personal factors which are found are used as the best predictors of in recent studies on EI. The results of the study show that education is a positive factor affecting emotional intelligence of employees in the U.S.
