## Entrepreneurial Thinkers: An Imperative Asset to Corporations

Entrepreneurial thinkers are now an imperative asset to corporations. Corporations' employees are getting younger, as our students are entering the professional world, they are expected to use entrepreneurial thinking and growth mindsets to succeed.

In a recent article, management advisor Anand Chopra-McGowan states, "…leaders with a growth mindset are far more likely to adapt, push for change, and encourage others do the same — a skill that is needed to succeed in today's workforce. The good news is that your ability to adapt can be developed…." Based on his research and experience, he has several suggestions for us. First, create your own job description, and then be ready to grow and adapt in your new role. Secondly, be aware of the external environment of the business and help your company adapt to that environment internally. "… when you are aware of the environment around you, you are better prepared to foresee and respond to competition," Chopra-McGowan says. Finally, stay focused on the mission and purpose of the business to identify emergent opportunities due to the changing environment.
