he <u>SUNY Old Westbury SOB</u> would like to officially welcome, **Dr. Timothy E. Sams** as the new president of SUNY Old Westbury. Dr. Sams is a veteran administrator with a track record of student-focused leadership and success. He succeeds Dr. Calvin O. Butts, III, who retired at the end of August 2020 after nearly 21 years leading the college.

Dr. Sams is from Syracuse, New York. He earned a bachelor's degree in History and Sociology from Union College in Schenectady, New York, a Masters in Africana Studies from the University at Albany, and a Ph.D. in African American Studies from Temple University. He is an MSI Aspiring Leaders Fellow and recipient of the <u>2020</u> <u>Champions for Student Success Award from</u> <u>American Campus Communities</u>.

"Assuming the presidency of SUNY Old Westbury is an honor and the highlight of my career and I am proud to follow President Emeritus Butts in this capacity," said Dr. Sams. "I have spent three decades seeking to transform students' lives through access, excellence, success and impact. #### FACULTY IN THE SPOTLIGHT

Professor Oztimurlenk recently had a research paper accepted for publication.

Oztimurlenk, S. & Yilmaz B. (2020). The Relationship between Emotional Intelligence and Information Behavior of Academics in Hacettepe University. *Information Management*, 3(2) (Forthcoming).

The paper looks at how emotions play a crucial role in teaching and learning as it involves continuous human interaction. The results of the study show that EI is a factor affecting information behavior of academics in terms of only information share dimension. This research puts an emphasis on the correlation between academics with high emotional intelligence and the vision of sharing information in the right way and at the right time. As a practical implication, educational institutions may consider different ways to increase their faculties' EI levels by offering more EI training programs or hiring emotionally intelligent academics to have well-organized information flow.



Professor Ebrahimi presented a virtual presentation to at the IEEE ISTAS20 Conference at Arizona State University on November 15, 2020 entitled



"In Search of a Pattern and Algorithmic Code for COVID-19: A participant self-customized diagnostic awareness system and simulator to comprehend, combat, coexist, cope and trace."

The aim of this project is to formulate an algorithm to tackle a solution to COVID-19. The implication of this study is to produce a guideline for others to initiate their own participant's system to find a pattern and formulate an algorithm for the pandemic.

All courses are offered online in Blackboard, asynchronous (no real time video conference meetings), and typically require 2-4 hours per week to complete so participants can fit them into their schedule. These programs are all priced well below the national average and CPD points can be used for all. You also can enroll in one course in each Certificate program or register for three to get a discount.
